The Southern Alberta Energy from Waste Association (SAEWA) was developed in (2012) and is registered as a non-profit society in incorporation (2012 – 2017) which is comprised of a Board of Directors (12); and an Executive Officer Committee (4). 
### 4. SAEWA Directors / Board Roles & Responsibilities

All Board of Director terms are served as 2 year terms, in early 2018 at the next Annual General Meeting (2017) the elections will be considered ODD year and therefore there are (6) positions available for election / reelection to the Board as noted in the organizational chart preceding.

The SAEWA Board of Directors will follow the Governance Plan in priority of achieving the mission. The SAEWA Bylaws (2014) are fundamental to the association regulations that are to be followed in accordance with carrying out the mission objective. SAEWA Board meetings are held on the last Friday of each month at rotating locations situated within the SAEWA membership footprint. e.g. Town of Vulcan; *and whereby appointed members representing their councils by appointment to the SAEWA Board will agree to not miss (3) consecutive monthly meetings in a row* (www.saewa bylaws 2014 / voting and elections), to act as a liaison and information relay to their respective municipal councils. The previous month meeting minutes are summarized and distributed to board representatives in draft copy within 1 week following Board meeting dates. The draft minutes are reviewed and approved as final by the Board at the following Board meeting within 30 days after the date of draft (then can be found posted at <u>www.saewa.ca</u> / background documents / board meeting minutes). The SAEWA administration will also be expected to maintain current contact information of Directors, in addition to receiving a letter of appointment to the SAEWA Board; all membership registration documents are to be current year and maintained in order along with receipt of payment of dues in good standing at least 1 month prior to setting the Annual General Assembly date and prior to distribution of voter documents as set out in the <u>www.saewa.ca</u> / saewa bylaws: voting / directors and officers.
